Victoria Road recognises the value in both assessing risk and identifying risk benefits for our young people. All playgrounds and play practices offer a level of risk, and there is a clear history and evidence for children experiencing 'free play' over generations. Schools providing opportunities for physical exertion, mental stimulus and social interaction is a standard practice worldwide. Risks cannot be reduced to nil, therefore this risk assessment identifies risks and appropriate control measures, as well as recognising the significant benefits for the children. This risk assessment has been completed in conjunction with staff and pupils at Victoria Road Primary School.

Concerns, changes in risk management practice or minor injuries that are seen by staff to be significant should be reported to SLT for discussion with the team. The correct Incident Report form should be used for any injuries sustained.

Prior to accessing the playground children will review this document with staff and agree to treat all participants and resources in accordance with school values. We will practise respect, establishing a routine that ensures appropriate care for and storage of all resources.
